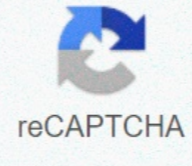

If one of the above requirements is not fulfilled, the alleged marriage will be annulled. Age Requirements in Mississippi are men who are at least 17 years old and women who are at least 15 years old are legally able to get married. Under Mississippi's marriage license laws, any applicant under 21 must have the consent of their parents (or guardians) before they marry in Mississippi. County clerks may issue a marriage license only to an applicant who is less than 21 years old if the following requirements have been met: Marriage license application must be in writing and include: Names, ages and addresses of parties Names and addresses of the applicant's parents (or the names and addresses of the applicant's guardian or immediate family members if they do not have parents) Witness Signatures, and any other details required by the State Health Board Proof of the Age of Applicants (birth certificate, baptismal record, military statement, military ID, life insurance policy, insurance certificate, school record, driver's license, or other official age-confirming document are acceptable) affidavits showing the applicant's age, made by the applicant's father, mother, guardian or next of kin of any clerk who issues a marriage license is subject to a fine of \$50 to \$500.
